

## 10 Days of Giveaways Official Rules

**NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. ENTRANTS ARE INVITED TO COMMENT ON THE RESORT'S INSTAGRAM POST TO NOMINATE A FRIEND FOR A COMPLIMENTARY EXPERIENCE AS OUTLINED IN THE CORRESPONDING POST. ONE WINNER WILL BE RANDOMLY SELECTED FOR EACH CONTEST BETWEEN DECEMBER 11, 2018 AND DECEMBER 22, 2018, BASED ON THE AUTHENTICITY AND THOUGHTFULNESS OF THEIR NOMINATION.**

**1. ELIGIBILITY.** 10 Days of Giveaways at The Resort at Pelican Hill (the "Contest") is open only to legal residents of the United States of America who are 21 years of age or older at the time of entry. One winner will be randomly selected for each contest.

Sponsor may include the name and city of the entrant in connection with posting an entry to the Sponsor's Instagram, Facebook, Pinterest pages or the Website. Limit one (1) entry per person (but not per household). Automated entries are not permitted. Use and/or creation of multiple social media accounts by the same entrant to submit multiple entries are prohibited. Should more than one (1) entry per person be received, Sponsor reserves the right to void all such entries. Sponsor is not responsible for late, lost, stolen or misdirected entries or human error. ### 4. ENTRY PERIOD

All entries received between 12:00 a.m. on the start date of the Entry Period and 11:59 p.m. PST on the end date of the Entry Period will be eligible for the judging panel selected winner.

**5. ENTRY CONTENT REQUIREMENTS.** Entrants must be 21 years of age or older, release Facebook of responsibility, and agree to Facebook's terms of use. The Contest is in no way associated with Facebook. Any entry deemed inappropriate or unsuitable, in Sponsor's sole discretion, may be disqualified at any time. Entries may not contain material that, in Sponsor's sole discretion, is inappropriate, indecent (including but not limited to nudity or pornography), profane, obscene, hateful, tortuous, defamatory, slanderous or libelous (including words or symbols that are widely considered offensive to individuals or groups of a certain race, gender, national origin, ethnicity, religion, marital status, sexual orientation, or socioeconomic status) or that is otherwise threatening or harassing to any individual, partnership, corporation or political body. **6. SELECTION OF WINNER.** All eligible entries will be included in a drawing where one (1) winner will be randomly selected from all eligible entries. Limit one (1) Prize for (1) one winner. No information regarding selection of entries will be disclosed. The Prize winner will be selected by the date listed in Section 4.

The winner must return the Affidavit of Eligibility and Liability and Publicity Release within two (2) days of date of the first notification attempt or prize may be forfeited and an alternate winner may be selected. **12. ADMINISTRATION.** Sponsor Entities are not responsible for lost, late, misdirected, illegible, altered, garbled, incorrect, incomplete, delayed or undelivered entries, or for technical, hardware, software, server, Internet Service Provider (ISP), or telephone malfunctions of any kind, or by any human error. Sponsor Entities are not responsible for any errors or problems that may occur in connection with the administration of the Contest, the incorrect uploading of any entry, the processing of entries or the announcement of winners.
