

**The Resort at Pelican Hill®
Holiday Sweepstakes Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. Void where prohibited. A purchase will not improve your chances of winning.

1. Eligibility. The Resort at Pelican Hill Holiday Sweepstakes (the “Sweepstakes”) is open only to legal residents of the United States of America who are 18 years of age or older at the time of entry. Employees, associates, officers, directors and contractors of Sponsor and its affiliated companies and advertising or sweepstakes agencies, and their immediate family (spouse, parents, siblings and children) or persons residing in the same household, are not eligible to participate or to win a prize. The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Any Entry determined by Sponsor in its discretion to violate these Official Rules will be disqualified and ineligible for any prize.

2. Timing. The entry period begins on Thursday, December 16, 2021 at 11:00 a.m. Pacific Time (“PT”) and ends on Sunday, December 19, 2021 at 11:59 p.m. PT (the “Entry Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.

3. Sponsor. Irvine Management Company, 550 Newport Center Drive, Newport Beach, CA 92660 is the sponsor of the Sweepstakes (“Sponsor”). Sponsor reserves its right, in its sole discretion, to modify, cancel or terminate this Sweepstakes if any fraud, technical failures or any other factor impairs, corrupts or interferes with the administration, security, fairness, integrity or proper play of the Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook, Instagram or Twitter.

5. How to Enter. Eligible Entrants (each, an “Entrant”) may enter via Sponsor’s Instagram page found on <https://www.instagram.com/pelicanhillresort>. Entrants must follow the entry instructions to follow @pelicanhillresort on Instagram, tag two friends with #ad in the comments and sign up for our email list at the link in our bio. Limit one (1) entry per person. Automated entries or entries by commercial sweepstakes services are not permitted. If more than one (1) entry is received from an Entrant, or if an automated entry is received, Sponsor reserves the right to disqualify all the Entrant’s entries. By entering the Sweepstakes, entrants agree to be contacted by Sponsor for winner notification and by Sponsor, its affiliates and others for advertising purposes.

6. Prizes. Five (5) prizes will be awarded to one (1) winner. Prizes are Two Exclusive Pelican Hill Virtual Paint Class Kits by Timree Gold (\$100 Approximate Retail Value each), One \$250 Resort Gift Card, One 60-minute Spa Treatment for Monday - Thursday (\$260 Approximate Retail Value, excluding Hydrafacial), and One Round of Golf for Sunday - Thursday (\$315

Approximate Retail Value). All reservations based on availability and blackout dates. Golf and Spa prizes include applicable taxes, gratuity and service charge. All federal, state, and local taxes and other expenses and costs, not expressly listed as included in the Prize, are the winner's sole responsibility. No cash alternative, prize substitution or other changes will be allowed. The Prize is nontransferable and may not be combined with any other offers or promotions.

7. Selection and Notification of Winners. The winners will be selected by a random drawing on or about Monday, December 20, 2021 from all eligible entries received during the Entry Period. Odds of winning the Sweepstakes depend on total number of eligible entries received. The winner need not be present to win. The Potential winner will be notified by email at the email address provided on the entry form within one (1) week of the drawing. The potential winner must respond by providing requested information and may be required to sign and return to Sponsor an Affidavit of Eligibility and Publicity Release, which may include W-9 information for 1099 tax reporting, within two (2) days of notification. If the potential winner does not respond with requested information, is ineligible or unwilling to accept the Prize, or does not return the signed Affidavit of Eligibility and Publicity Release and W-9 information if applicable, within two (2) days of notification, an alternate potential winner will be selected at random from all remaining eligible entries and notified in the same manner. The Prize will be mailed to the winner at the winner's postal address in Sponsor's records. The winner should allow two (2) weeks after winner confirmation for delivery of the Prize.

8. Publicity. Except where prohibited, participation in the Giveaway constitutes the winner's consent to Sponsor's, its affiliated companies' and agents' use of the winner's name, likeness, photograph, recordings, voice, opinions, business name and/or hometown and state (together, "Likeness") for promotional purposes in any media, worldwide, without further payment or consideration.

9. Release. Sponsor, Facebook, Instagram and Twitter, and their affiliated companies and their employees, directors, officers, shareholders, partners, members and agents (collectively, the "Released Parties") are not responsible for printing or typographical errors, stolen or fraudulent entries, or entries that are delayed, garbled or lost due to computer or electronic malfunction or human or technical failures. The Released Parties are not responsible for any injuries, losses, damages or costs of any kind arising in connection with, or as a result of, any entrant's participation in the Sweepstakes or the winner's acceptance or use of the Prize. Entrant hereby releases and agrees to indemnify and hold the Released Parties harmless from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of participation in the Sweepstakes, entrant's acceptance or use of any Prize, or any use of information about entrants, as an entrant or winner.

THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.” Being aware of said code section, entrant hereby expressly waives any rights he/she may have thereunder, as well as any other statute or common law principles of similar effect.

10. Taxes; Other Charges. The winners are solely responsible for payment of all federal, state, and local taxes on the Prize and for any expenses not specifically mentioned in the Prize description. Sponsor may request information from the winner for tax reporting. Entrants are responsible for all online charges of any internet service or wireless carrier.

11. Governing Law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of California, without regard to its conflict of law provisions, except as to matters relating to arbitration, which shall be governed by the Federal Arbitration Act.

12. Disputes. The Federal Arbitration Act governs the interpretation and enforcement of this provision and this provision is deemed to be a “written agreement to arbitrate” pursuant to the Federal Arbitration Act. Any dispute with a Giveaway Party arising out of or relating to the Giveaway and/or the Prize will be decided only by binding arbitration, individually and not on a class-wide or representative basis. Any arbitration will be administered by the American Arbitration Association under its applicable rules and will take place in Orange County, California.
